

# Cookies

ETTC Group uses cookies to record the preferences of visitors, and therefore to be able to optimise the design of its web site. Cookies are small files which are stored on your hard drive. They ease navigation and increase the user-friendliness of a web site.

Cookies also help us to identify the most popular sections of our web site.

This enables us to provide content that is more accurately suited to your needs, and in so doing improve our service. Cookies can be used to determine whether there has been any contact between ourselves and your computer in the past.

Only the cookie on your computer is identified. Personal details can be saved in cookies, if you have consented to this, for example, in order to facilitate secure online access so that you do not need to enter your user ID and password again.
